### **Position Duties:**

- Serve as a maintenance worker performing a variety of project maintenance tasks which include: Picnic table repair, installation of signs, painting, road repair, repair of charcoal grills, erosion control, removal of dead trees and brush from recreation areas or maintenance of flood control structures.
- Removal of dead trees and brush from intake dams and cleaning of storm catch basins.
- General housekeeping in the maintenance and operations buildings and in the park administration building.
- May on occasion be required to operate small riding mowers, and medium size tractor with flail mower and front-end loader. Operates weed eater, power blowers and other similar small power tools. Uses carpentry and plumbing tools.
- Perform park and dam maintenance activities. May lift up to 40 pounds while working on the dam or recreation area projects.

**Qualifications:** Basic Requirement for Position:

Minimum Qualifications (Screen Out Element): Ability to do the work of a General Laborer without more than normal supervision. Your resume must demonstrate you have the ability to operate small hand and power tools, experience with facilities maintenance, and/or use of landscaping tools.
