The quarry, which occupies approximately 3.54 acres of the 7.24 acre review area, was used to supply rock for local building

projects until the early 1900's. At which time the quarry was rapidly flooded when the excavation intersected groundwater in a fracture that allowed water to fill the quarry. The quarry has remained flooded to this day. The flooded quarry is an isolated man-made impoundment located approximately 500 feet north of the Brandywine Creek. Based on the review of 1906 U.S. Geologic Survey (USGS) Topographic map and the landscape position of the surrounding lands, it appears the quarry was excavated wholly in an upland. The quarry is currently located within the 100-year floodplain (Zone AE) of the Brandywine Creek, based on the elevation of the quarry. However, the quarry was artificially created and it is located outside of the natural drainage pattern of Brandywine Creek; as such, it does not exhibit the same beneficial aspects associated with natural floodplains.

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. The determination whether a significant nexus exists is determined in Section III.C below.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: The primary hydrologic feature located on the project site is the quarry. As previously discussed the quarry flooded in the early 1900's while it was actively being mined. The quarry reportedly, contains approximately 37 million gallons of water, with a maximum depth of 52-ft. The quarry is not directly connected to waters of the United States. The sole source of water to the quarry is groundwater and there is no outfall associated with the quarry. There is no surface flow connection between the quarry and Brandywine Creek. Based on the elevation of the quarry, it is located within the 100-year floodplain (Zone AE) of Brandywine Creek. The hydrology within the quarry is non-tidal, while the Brandywine Creek is a non-headwater stream and is tidally influenced due to its connection with the Christina River which connects to the Delaware River. The hydrology of the wetland near the upland/wetland boundary appears is a direct result of the quarry hydrology and has no connection to the Brandywine Creek.
