B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Inspection of the project area revealed that the area of concern has been an existing upland parking lot since the 1950s. No waterways or wetlands could be identified in historic aerial photography within this area. Likewise, when inspecting the area surrounding the subject parking lot, surrounding areas were themselves all fully developed, urban uplands comprised of streets, sidewalks and buildings with no identifiable waterways within the area. Similarly, the project area is very close to being at the top of a hill. This determination is only for those areas reviewed as part of the report of alleged unauthorized work.
