B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Two areas of suspected wetlands occurred on the project site. The western area contained some hydrophytic vegetation, but did not have a dominantly hydrophytic community. This area also did not have hydric soils present. The second area of apparent wetlands was a sediment basin, constructed from uplands, servicing an existing surface mine. The area was part of an

operating mine and was subject to reclamation as a condition of the state mining permit. Neither area meet the requirements of WOUS and are, therefore, dry land.
