**B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:** The property is upland forest with predominantly non-hydrophytic vegetation consisting of *Acer rubrum* (red maple), *Prunus serotina* (black Cherry), *Fagus grandifolia* (American beech), *Epifagus virginiana* (beechdrops), *Dennstaedtia punctilobula* (hay-scented fern), *Lycopodium obscurum* (tree clubmoss) and *Maianthemum canadense* (Canada mauflower). The soils were well drained non-hydric mineral soils and there was no evidence of hydrology.
