NOTE: Aquatic features including waters and wetlands are present outside of the review area. The Clean Water Act jurisdictional status of these aquatic features has not been evaluated.



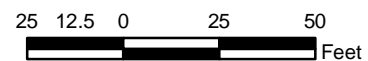
