Features A, B, and C (highlighted in yellow on the enclosed drawing E-1) within the "Limited Study Area" (outlined in red on the enclosed drawing E-1) were field-determined by USACE on 10 June 2020 to be ephemeral stormwater conveyance features, with Feature A draining overflow from an existing stormwater basin at the Grand View Health Hospital property (located to the north of the "Limited Study Area"); and Features B and C draining stormwater from the existing 716 Lawn Avenue residential property (located to the north of Features B and C). This is in agreement with the topography of the "Limited Study Area" and the surrounding land parcels, where elevation decreases from north to south.

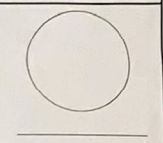
