B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: The project site is located above the Ordinary High Water Line of the Lehigh River. The levee is covered in very large riprap to an unknown depth, no field indicators of wetland hydrology were observed during the site inspection and only sparse vegetation was observed growing from between the riprap.
