- **B.** Typical year assessment(s): Assessment of the subject site on June 30, 2020 by the Corps of Engineer's Antecedent Precipitation Tool revealed that site conditions during the site assessment was drier than normal, based on 30 years of previous precipitation data, even during the "dry season".
- **C.** Additional comments to support AJD: This jurisdictional determination is associated with an investigation of unauthorized work. The extent of the investigation is limited to the area of work. Waters and wetlands may exist outside of the area of investigation that were not assessed.
