B. Typical year assessment(s): [Use of the Corps' Antecedant Precipitation Tool shows that, based on the previous 30 years, the amount of precipitation for the date of the site visit was a 17, which was wetter than normal during the dry season for that time of year. Conversations with the owner and a neighbor during the site visit revealed that the area was typically "too wet to mow" in most years.](#)
