- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.  
Explain: **All water/wetland features at the subject property were determined to have no hydrologic connection to Waters of the U.S. The nearest water body is the man-made Delaware Canal, which abuts the subject property to the west. Subterranean leakage from the canal into the surrounding groundwater table, combined with storm water run-off from surrounding properties are the hydrologic sources for the wetland and ponded water features at the subject property. Thus, given the lack of a**

**hydrologic connection to Waters of the U.S., the water/wetland features at the subject property were determined to be non-jurisdictional. This determination of non-jurisdiction is in agreement with a U.S. Supreme Court decision (Solid Waste Agency of Northern Cook County v. U.S. Army Corps of Engineers, No. 99-1178, January 9, 2001), where USACE has determined that any waters/wetlands on the subject property do not meet the current criteria of Waters of the U.S. under Section 404 of the Clean Water Act. The Court ruled that isolated, interstate waters can no longer be considered Waters of the U.S. based solely upon their use by migratory birds.**

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

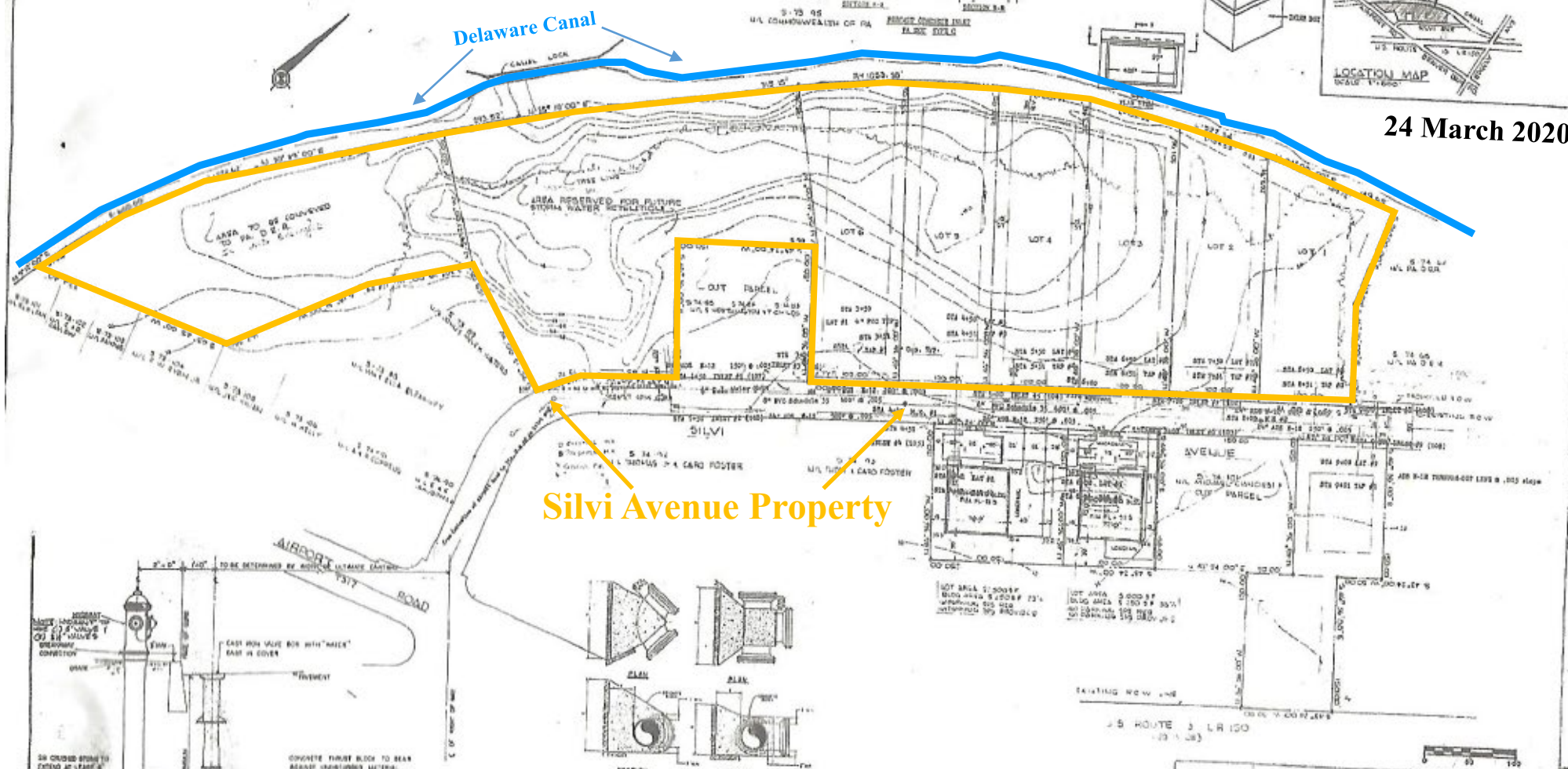

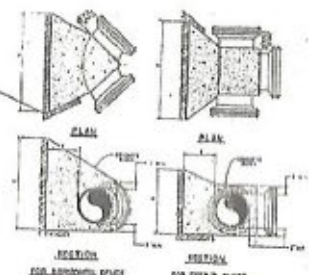
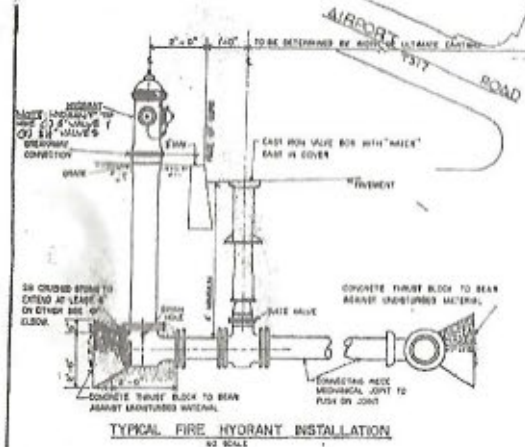
