- **B.** Typical year assessment(s): No assessment was performed using the Corps' Antecedent Precipitation Tool, as it wasn't working the date of this JDIS. The site was inspected at a period that the precipitation was normal or above normal, based on familiarity with the region.
- **C.** Additional comments to support AJD: This JDIS is associated with the inspection of an alleged discharge of fill material into waters of the US. This investigation was limited to only those areas of recent work. Waters and wetlands may exist on the property that were located outside of the limit of this investigation and their jurisdictional status was not determinted.
