Waters of the U.S., as defined at 40 C.F.R. Section 232.2(q), within the State of New Jersey, will be regulated by the New Jersey Department of Environmental Protection as part of their State program, with the exception of those waters which are presently used, or are susceptible to use in their natural condition or by reasonable improvement as a means to transport interstate or foreign commerce shoreward to their ordinary highwater mark, including all waters which are subject to the ebb and flow of the tide shoreward to their mean high water mark, including wetlands adjacent thereto. For the purposes of this agreement, the Corps will retain regulatory authority over those wetlands that are partially or entirely located within 1,000 feet of the ordinary high water mark or mean high tide of the Delaware River, Greenwood Lake, and all water bodies which are subject to the ebb and flow of the tide."

Feature A at the subject property is located approximately 230.0-linear feet from the mean high tide line of Barnegat Bay, a Section 10 waterbody subject to the ebb and flow of tide. Thus, in accordance with the 04 March 1997 MOA between the State of New Jersey and the Department of the Army, Feature A falls under the jurisdiction of the Department of the Army (USACE). Feature A was determined by USACE to be non-jurisdictional. Rationale for this determination is the absence of a hydrological connection between Feature A and Waters of the U.S. (Barnegat Bay). Storm water runoff and groundwater are the hydrologic sources for Feature A. Thus, given the lack of a hydrologic connection to Waters of the U.S., Feature A was determined to be non-jurisdictional. .

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

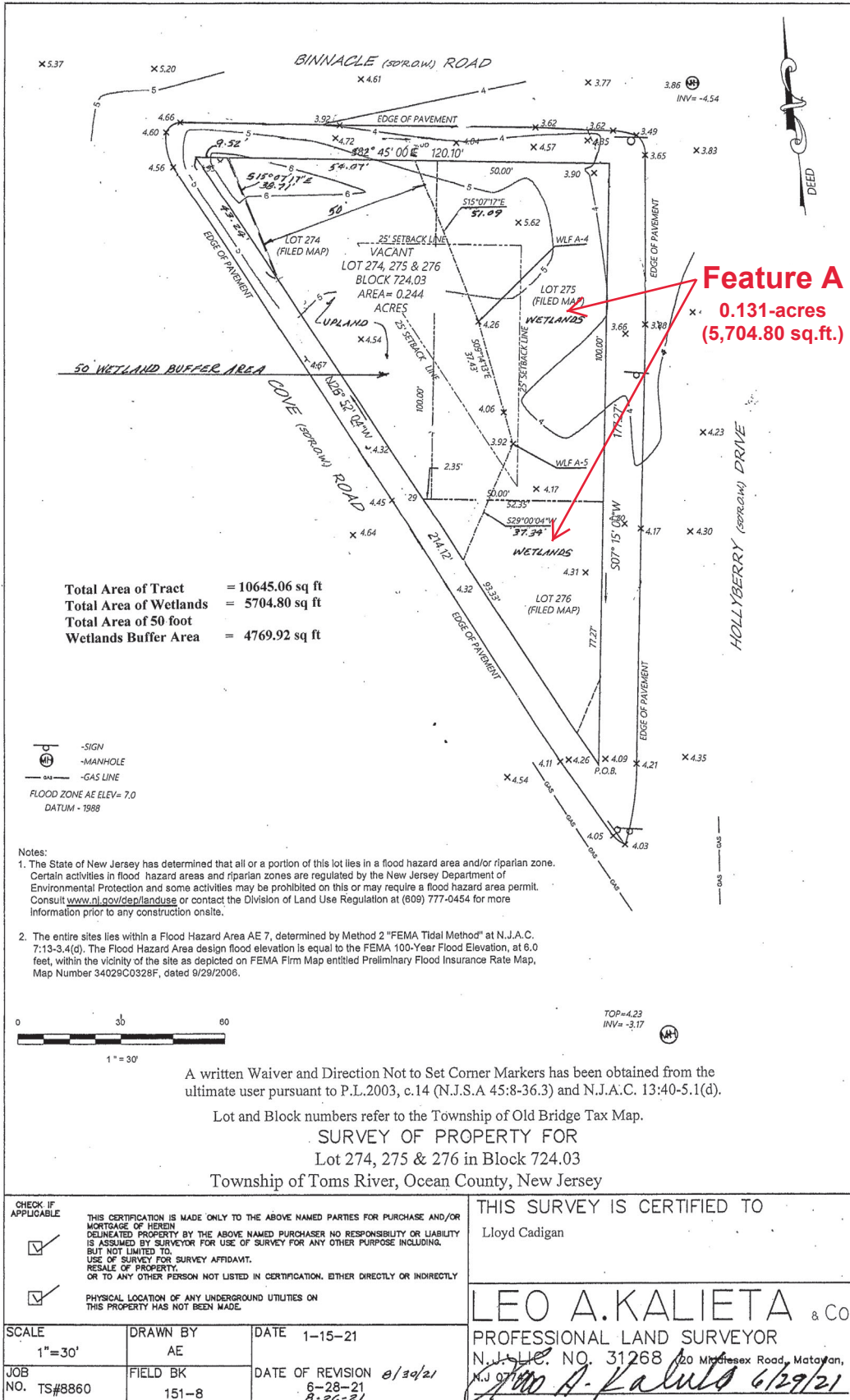
