B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Two depressional areas were questioned by Brand Environmental Consultation Services. Neither of the areas had field indicators of wetland hydrology or field indicators of hydric soils during the site visit. Vegetation was not fully assessed but it did not appear to be a hydrophytic plant community.
