- A) The largest wetland receives its hydrology from water pumped from a coal strip mine which drains through a forested channel, receives some precipitation draining from the forested areas, then opens up into a depression where a saturated wetland has formed. The water then drains further through a small ditch that then drops into an old coal pit and sits there until it either evaporates or drains to groundwater. No connection to a surface water was noted.
- B) The other 2 vegetated wetlands are small depressions that retain precipitation but have no outlet to any surfacewater.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** It should also be noted that the site of the wetlands was originally a construction site (strip mining) and the property owner proposes to continue mining through the area. As such, the subject wetlands would also meet the definition of non-jurisdictional waters at 33 CFR 328.3(b)(9). Although the original extent of Beaver Creek, and possibly adjacent wetlands, may have been located on the property historically, since 1967 or thereabout (i.e. prior to the Clean Water Act), the site had been so disturbed (excavated and/or filled) with the creek diverted or otherwise obliterated on the property, the existing wetlands would be considered developed on uplands.
