**Feature RX (0.03-acres), Feature RXA (0.18-acres), and Feature RXB (0.03-acres) at the subject property are all located approximately 1,240.0-linear feet from the mean high tide line of Schuylkill River, a Section 10 waterbody**

subject to the ebb and flow of the tide. Features RX, RXA, and RXB are all sited within a man-made basin constructed to collect stormwater runoff from the onsite, upland asphalt-paved tractor trailer parking lot area, with overflow conveyed offsite via subsurface piping.

Stormwater runoff and groundwater were determined to be the hydrologic sources for Features RX, RXA, and RXB. Thus, given the lack of a hydrologic connection to Waters of the U.S., Features RX, RXA, and RXB were determined to be non-jurisdictional. This determination of non-jurisdiction is in agreement with a U.S. Supreme Court decision (Solid Waste Agency of Northern Cook County v. U.S. Army Corps of Engineers, No. 99-1178, January 9, 2001). The Court ruled that isolated, interstate waters can no longer be considered Waters of the U.S. based solely upon their use by migratory birds. Additionally, given the distance, as well as the existing industrial properties and urban infrastructure located between Features RX, RXA, and RXB and the bulkheaded Schuylkill River, Features RX, RXA, and RXB were determined to be wetlands which are not adjacent to a TNW.

The remainder of the subject property is comprised of dry land in its entirety.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

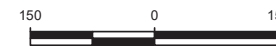
