B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Site visits were conducted in July, August and September of 2022 under normal conditions. Using the 1987 Corps of Engineers Wetland Delineation Manual along with the Regional Supplement, it was determined there are no aquatic resources in the approximately 8 acre review area.
