If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Area "WAK" (i.e., Salem Canal) is a non-tidal water and is listed on the District's Navigable Water Study. Areas "WA", "WB" and "WP" (identified as Tidal Ditch) are all subject to the ebb and flow of the tide. Therefore, these four features are subject to Section 10 of the RHA as well as Section 404 of the CWA (TNWs). Areas "WU", "WAA", "WS", "WT" and "WV" are all geographically and hydrologically isolated wetlands with no direct hydrologic surface connection flowing into or out of these features. These features are located at such a distance from any TNW or tributary water that they would not be subject to inundation by flooding by one of the TNW's in a typical year. Therefore, this office has determined that these isolated features would not be subject to Federal jurisdiction based on SWANCC guidance. All other aquatic resources delineated on the above referenced plan set are assumed by the State of New Jersey. The Army Corps of Engineers does not issue jurisdictional determinations for assumed areas (see Assumption letter dated 28-AUG-2020).
