Summarize overall biological, chemical and physical functions being performed: System 1 consists of an seasonally intermittent stream (Waterbody A) and adjacent palustrine wetlands (Wetland 3, Wetland 4, and Wetland 5). Wetland 3 and Wetland 5 are located south of Fisher Road and are separated by a culvert beneath a former access drive. Wetland 3 outlets to a culvert beneath Fisher Road into Waterbody A. Waterbody A originates from this culvert and continues north into Wetland 4. Ordinary high-water marks and defined beds and banks were observed within the limits of Waterbody A within the subject site. Wetland 4 abuts Martin Branch, which connects to Old Mill Creek (tidal waterbody), approximately 3-4 miles downstream. As such, the tributary in combination with wetlands 3, 4 and 5 contribute directly to the physical, chemical and biological integrity of the downstream traditional navigable waterway.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: System 1 consists of an intermittent stream (Waterbody A) and adjacent palustrine wetlands (Wetland 3, Wetland 4, and Wetland 5). Wetland 3 and Wetland 5 are located south of Fisher Road and are separated by a culvert beneath a former access drive. Wetland 3 outlets to a culvert beneath Fisher Road into Waterbody A. Waterbody A originates from this culvert and continues north into Wetland 4. Ordinary high-water marks and defined beds and banks were observed within the limits of Waterbody A within the subject site. Flow was observed in May and December. Tributary is fed by ground water from the abutting wetlands during the fall and winter months during high ground water. The stream flows intermittently but seasonally. Wetland 4 abuts Martin Branch, which connects to Old Mill Creek (tidal waterbody), approximately 3-4 miles downstream.

Wetland 1 and Wetland 2 are geographically isolated and do not have significant nexus to waters of the United States. The ditch between Wetland 2 and Wetland 5 that appears to be a connection does not convey water between the two wetlands as the ditch elevation increases towards the middle of the ditch to where it is non-existent. Furthermore, the ditch does not exhibit an ordinary high water mark, nor defined bed and banks and is dug in uplands. As such, Wetland 1 and Wetland 2 are non-navigable, intrastate, non-jurisdictional features, whereas the ditch is dug wholly in uplands, draining only uplands and has no connection downstream is also a non-jurisdictional feature.
