Summarize overall biological, chemical and physical functions being performed: The forested wetlands abutting the channel serves as riparian habitat which buffers the stream from active agricultural land and limited urbanized areas. It serves as wildlife habitat and a corridor for wildlife movements. The opportunity for high wildlife and water quality functions exists.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Based on historical aerial imagery, the borrow pit was excavated between 1937 and 1954. The borrow pit is designated as a gravel pit on the 1955 USGS Topographic Quadrangle. The borrow pit is well defined with elevated slopes and there is no surface connection to the non-tidal wetlands or the unnamed channel on the parcel. The borrow pit cannot be categorized as an (a)(1) through (a)(5) water in accordance with the definition of waters of the United States. Because the borrow pit was created by excavating dry land, the pit is an excluded feature as described in the preamble of the November 13, 1986, Federal Register (51 FR, 41217). As such, in accordance with 33 CFR 328.3, the borrow pit does not meet the definition of waters of the United States.
