# MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), 1 NAP-2024-00748-85 MFR 1 of 1.2

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup>

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the 2023 Rule as amended,

- 3. REVIEW AREA. The review area is approximately 2.44 acres on tax map parcels 533-11.00-244.00, 533-11.00-245.00 and 533-11.00-246.00 along the southwest of the intersection of Zion Church Road and Deer Run Road in Selbyville, Sussex County, Delaware. The central coordinates for the site are 38.481731°N, 75.155039°W.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), THE TERRITORIAL SEAS, OR INTERSTATE WATER TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The Nearest TNW (Dirickson Creek) is 1.22 miles east from the review area. Dirickson Creek was determined to be a TNW based on the National Wetland Inventory map identifying it as an estuarine water body subject to the ebb and flow of the tide. However, the aquatic resources within the review area lack a continuous surface connection to any other aquatic resources.<sup>6</sup>

A stand-alone TNW determination for a water that is not subject to Section 9 or 10 of the Rivers and Harbors Act of 1899 (RHA) is completed independently of a request for an AJD. A stand-alone TNW determination is conducted for a specific segment of river or stream or other type of waterbody, such as a lake, where upstream or downstream limits or lake borders are established.

# 8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

Palustrine Forested Wetlands is approximately 0.585 acre and is part of the Palustrine Scrub Shrub Wetlands. Surface elevations within Palustrine Forested Wetlands ranges from approximately 13.9 feet to 15.3 feet. The elevation beyond the wetlands increases to approximately 17 feet. The topography is consistent with a depressional wetland that has no outlet. Palustrine Forested Wetlands is geographically separated from any other aquatic resource with no continuous surface connection to an (a)(1) through (a)(3) water. As such, Palustrine Forested Wetlands does not meet the definition of an (a)(4) adjacent wetland, nor does it meet the definition of a waters of the United States.

Palustrine Scrub Shrub Wetlands is approximately 0.026 acre and is part of the Palustrine Forested Wetlands. Surface elevations within Palustrine Scrub Shrub Wetlands ranges from approximately 13.9 feet to 15.3 feet. The elevation beyond the wetlands increases to approximately 17 feet. The topography is consistent with a depressional wetland that has no outlet. Palustrine Scrub Shrub Wetlands is geographically separated from any other aquatic resource with no continuous surface connection to an (a)(1) through (a)(3) water. As such, Palustrine Scrub Shrub Wetlands does not meet the definition of an (a)(4) adjacent wetland, nor does it meet the definition of a waters of the United States.
